# From the General Manager's Desk

Greetings to everyone from the entire team here at the Edgewater Beach Resort. 2020 has certainly been a year like none other. Hopefully each one of you and your families are safe and healthy.

The Resort was closed for 90 days due to the COVID-19 pandemic, and when we reopened, our occupancy levels were very high. The Resort remained busy all the way through to Thanksgiving. The team has done a tremendous job day in and day out preparing the Resort for our incoming guests and owners.

Our employees stayed strong and loyal to Edgewater. They worked on the front line daily to follow CDC and State guidelines including our new protocols by disinfecting the common areas, guest rooms, and work areas to protect our guests, owners and staff. Over 2,000 owners visited Edgewater in 2020 or exchanged to other locations.

The renovation project is 50% complete which includes brand new bathrooms, kitchens, furniture, drapes, artwork, refinished floors, painted walls, and the list goes on. The first phase of our renovation went well with a few items delayed due to the pandemic. The renovation company has completed Phase One including installing all the new

furniture and granite counter tops in the east and center units plus units 119, 122, 123, 124, 219, 222, 237, and 239. Phase Two for the remainder of the west building and ocean front units will soon begin with an expected completion date in April 2021.

I would like to thank our owners, guests, staff, vendors and the Board for adhering to all the mandates such as wearing masks, social distancing, hand washing, and staying home when ill. This has kept our property a safe and healthy place to visit despite the pandemic.

For all of you who have been cooped up far too long and need to get out and visit happy places like The Edgewater Beach Resort, call Taylor at 508-398-6922, and book an overnight stay or a weekend. Ask for the owner discount rate. Then bring a good book and escape to Dennisport and recharge your batteries.

We look forward to a fabulous 2021 and ask that all who visit continue to practice the same protocols which will enable us to stay open, so you can visit your piece of paradise here on Cape Cod!

## Call for Nominations to the Board



It's that time of year again when the Board is searching for owners who are interested in contributing their time and efforts to The Edgewater Beach Resort and its future. If you are interested, please submit your name to be a candidate and run in the upcoming election to serve as a member of the Board. There are two (2) seats up for election, each for a three (3) year term.

To throw your hat into the ring, you must complete and return a Candidate Information Form. The Form is enclosed here for your convenience. We hope you will take the time to complete and submit it to reach us no later than COB March 3, 2021. Please fax the form to 508-775-6396, or mail it to: Secretary, Edgewater Beach Resort, c/o VRI Americas, PO Box 399, Hyannis, MA 02601.

Please be aware that participation as a Board Member does not include compensation for your time but does require a lot of caring for and interest in the Edgewater Beach Resort. You must also be willing and able to attend at least six (6) meetings a year at VRI Americas' offices in Hyannis, virtually via Zoom, and, on occasion, onsite at the Resort. In addition, your participation may also be required, as needed, in between meetings via email, via Zoom, and/or telephone.

Please note that to run (and to vote in this election) you must be an owner and current with your maintenance fees and/or current with your financial obligations to the Resort by January 31, 2021.

A short biography of the candidates running, including a summary of their education and experience, will be mailed to all owners in March. Enclosed with that mailing will be the ballot to be used to vote for the candidates of your choice. The candidates selected will be notified in April and invited to attend the Board's organizational meeting in April. The selection will be announced to owners at the Annual Owners Meeting on May 1, 2021, online at [www.edgewatercapecodma.com](http://www.edgewatercapecodma.com), etc., and in the Resort's Summer 2021 newsletter.

## Renovations and Capital Improvement Projects

As you all know, renovations began in November 2019 and over seven months contractors reconstructed over thirty rooms at Edgewater. COVID-19 delayed work, slowed down shipping of supplies from China, North Carolina and our local Cape Cod cabinet maker, but construction teams worked diligently to get those rooms ready for travelers in 2020.

Laminate counter tops were temporarily installed in late May, and then in November 2020 they were replaced with granite in each bathroom and kitchen as originally specified by the design team from Granite State Furnishings out of New Hampshire.

All summer long exchange guests and owners commented to John, Albena and Taylor on how nice the rooms came out and that the owners were excited to come back next year and see the new furniture that was to be installed in November 2020. The wall art, drapes, and window treatments received rave reviews on our comment cards. RCI comments were up from last year,

and Edgewater was awarded their prestigious Silver Crown designation for 2021.

The renovation project started back up in mid-November 2020, furniture was delivered for the first thirty rooms, including case goods for bedrooms, dining rooms, and living rooms. The bedroom furniture included new dressers, nightstands, lamps, headboards, and mirrors. Living room furniture included new couches, lounge chairs, end tables, area rugs, coffee tables and lamps. New kitchen dining tables and chairs were installed. Phase two of the renovations is starting in February 2021 and is slotted to be completed in April 2021.

The staff is very proud of the renovated rooms and are excited to show them off. If you are looking to escape for a long weekend call the Front Desk, ask for the owner's rate, and book a rental. We look forward to showing each of you the new rooms upon arrival in 2021.

## Financial Update

COVID-19 has affected all Americans, making us choose what bills to pay now and what bills to put on a payment plan. For 2020, 60% of the owners paid upfront and others went on payment plans. Our typical deficit runs around \$500,000, however, with ongoing costs resulting from the fire at the studio units in April 2018, and the lack of rentals in 2020 due to COVID-19, our deficit has increased by \$301,000.

The Edgewater's Board of Trustees with the assistance of John Verity, General Manager, applied for financial assistance from the Small Business Administration (SBA) and was awarded a Payment Protection Plan Loan to keep the business open during COVID-19, keep employees working, and cut our deficit. In 2021, we plan to apply for forgiveness of this loan and hope the SBA will

accept our application. We also applied for a different loan from SBA, received it, and will start repaying that loan later this year. More information will be available at the Annual Meeting on Saturday, May 1, 2021.

However, we still have 1,200 owners that have not paid their financial obligation to Edgewater and that has a negative result to our bottom line. This number does include our former developer, NERM. Those units are in the rental program to help the Association financially. We are working with legal counsel to take legal action against the developer, but COVID-19 is delaying the process. Hopefully things will change in 2021, the courts will reopen, and court actions can proceed.

Or call the Resort directly at 508-398-6922 and make a credit card payment. Desk agents are available from 8:00 a.m. to 7:30 p.m. seven days a week.
