The total number of your votes may be equal to, but cannot exceed, the number of intervals you own. Simply mark your ballot with your choice for one candidate and indicate your interval(s) at the bottom of the ballot. Please note, you may vote only if you are current in your financial obligations to the Edgewater.

To be counted, this ballot must be signed and received no later than COB March 29, 2019. The votes will then be tallied and recorded, and the new Board will be announced at the May 4<sup>th</sup> Annual/Special Owners Meeting and in the Summer 2019 Newsletter. The newly elected Board member will be notified when the votes are tallied and will also be invited to the Board of Trustees meeting to be held on Monday, April 8, 2019.

The Board also wants to take this opportunity to announce the selection of our new General Manager (GM), John Verity. John brings to the Edgewater many years of experience in the hospitality industry. Most recently, John has served as the GM at another timeshare resort on the Cape. **Experience:** Born and raised in Rhode Island, Ducharme began his career in the hospitality industry in 1985 by developing the Holly Tree Resort in West Yarmouth (MA), his first vacation ownership property. Since then, he has played a key role in the development of vacation ownership properties on Cape Cod and in New Hampshire, generating sales in excess of \$300 million.

In 1993, he began the re-development of Pollard Brook Resort at Loon Mountain, a purpose-built resort in Lincoln, NH. The 17 original units have grown to more than 130, creating one of New Hampshire's 5-Star vacation ownership resort.

Additionally, he completed the refurbishment of the former Mill House Inn into a 121-unit purpose-built, luxury resort hotel, in downtown Lincoln, now known as InnSeason Resorts South Mountain. Currently, there site plan approval and development plans for a major 170 room resort complex which Phase I was completed in July 2016 will contain a conference facilities and spa known as Riverwalk Resort.

He is a former member of the Board of Directors of the American Resort Development Association (ARDA), and Chairman of the American Resort Development Association's Northeast Chapter, and a member of the Board of Directors of the North Country Center for the Arts. He is also chairman of Cape Cod YMCA.
